Following the correspondence received from prospective bidders (by email) and discussion held in the pre-bid meeting on 18th December 2019 at NISM regarding the above mentioned "Request for Proposal (RFP)", the following amendments are issued to the RFP:

3. Delivery Lead Time (Refer Section-5 on Page-8 of RFP)

The chosen supplier will be expected to complete the scope of work as stated in Section-3 within **ten weeks** from the date of issuance of the Purchase Order.

4. Experience (Refer Point A in Section 7 on Page-9 of RFP)

A) Experience

The bidders must be from telecommunication industry and must have very good experience in installation and maintenance of data circuit service. Past 7 years of

experience ending as on 30th November 2019 shall be taken into consideration. The bidder should have carried out installation, delivery and commissioning of data circuits of capacities as mentioned in Section – 3 and of the following order values:

i. Should have successfully executed **three** orders for Point-to-Point data circuits or Internet leased lines, each order not less than Rs. 5,00,000/-.

OR

ii. Should have successfully executed **two** orders for Point-to-Point data circuits or Internet leased lines, each order not less than Rs. 7,50,000/-.

OR

iii. Should have successfully executed **one** orders for Point-to-Point data circuits or Internet leased lines, each order not less than Rs. 10,00,000/-.

The details of customers must be provided as per Section- 1 of Annexure C. A copy of Purchase Order and Installation Reports must be submitted in envelope-1 as mentioned in Section 2.2.
