NISM has constructed a state of art educational campus at Patalganga near Panvel along Mumbai Pune Express way. The campus is having a built up area of 7.00 lakh sq. ft. on plot of lands admeasuring about 70 acre.

**It is intended to create natural water body with rubble pitching and walking track in the periphery of the water body by using paver blocks.** Applications are invited in the prescribed format for shortlisting of contractors for civil and development works relating to above areas in NISM Campus at Patalganga.

The estimated cost of work is Rs. 100 Lakh.

The contractor fulfilling following criteria (either 1. or 2. to 4.) may apply:

1. Should be a registered contractor under composite category with CPWD for value of Rs. 100 lakh or more.

OR

2. The contractor should have satisfactorily completed at least any of the following projects during the last 7 years:

- a. One similar project costing not less than Rs. 80 Lakh.

OR

- b. Two similar projects each costing not less than Rs. 50 Lakh.

OR

- c. Three similar projects each costing not less than Rs. 40 Lakh.

The period of 7 years for the purpose of having completed similar projects shall be from 01.03.2013 to 29.02.2020.

3. The annual average turnover of the contractor should not be less than Rs. 180 Lakh during the last 3 years ending March 31, 2019.
4. The contractor should have GST registration.

1. Incomplete applications or applications without proper proofs for establishing their credentials may not be considered for shortlisting.
2. Each page of the application shall be signed by the applicant. The application shall be signed by the person / persons on behalf of the organization having necessary authorization / Power to do so.
3. If the space in the proforma is insufficient for furnishing full details, the information shall be supplemented in separate sheets of paper stating therein the

part of the statement and serial number. Separate sheets shall be used for each part.

4. Applications containing false and / or inadequate information are liable for rejection. Applicant shall be disqualified at any stage at their risk and cost if they are found to have "Made untrue or false representation in the forms, statements and attachments submitted in proof of qualification and requirements."
5. While filling up the application form with regard to the list of important projects completed or in hand, the applicants shall include only those projects which individually cost not less than Rs. 40 Lakh for works relating to execution of civil works.
