National Institute of Securities Markets (NISM) invites applications for shortlisting of contractors for Audio Visual work in classroom at 2nd floor of Academic Block B in NISM Campus situated at Plot No: - IS-1 & IS-2, Patalganga Industrial area, Village: Mohopada (Wasambe), Opp. HDFC Bank, Taluka- Khalapur, District- Raigad, Maharashtra, Pin code: - 410 222. **The estimated cost of work is Rs. 9.65 Lakh (To be completed in a period of 75 days).**

NISM is a public trust, established by the Securities and Exchange Board of India (SEBI), the regulator for securities markets in India. NISM seeks to add to market quality through educational initiatives. It is an autonomous body governed by its Board of Governors.

Currently, NISM has been operating from its campus situated at Plot No: - IS-1 & IS-2, Patalganga Industrial area, Village: Mohopada (Wasambe), Opp. HDFC Bank, Taluka- Khalapur, District- Raigad, Maharashtra, Pin code: - 410 222. The campus is having a built up area of 7.00 lakh sq. ft. on plot of lands admeasuring about 70 acres.

NISM intends to shortlist eligible contractors for the captioned work.

Eligibility Criteria

The contractor fulfilling following criteria may apply:

1. Should have its office / establishment in Mumbai / Navi Mumbai/ Thane/ Raigad/ Palghar and Pune.
2. The contractor should have satisfactorily completed at least any of the following works during the last 7 years:
 - a. One similar work costing not less than Rs. 7.72 Lakh.
OR
 - b. Two similar works each costing not less than Rs. 4.83 Lakh.
OR
 - c. Three similar works each costing not less than Rs. 3.86 Lakh.

The period of 7 years for the purpose of having completed similar works shall be from 01.10.2015 to 30.09.2022

3. The annual average turnover of the contractor should not be less than Rs. 41.75 Lakh during the last 3 years ending March 31, 2021 / March 31, 2022.
4. The contractor should have GST registration.

Similar work(s) will mean Supply, Installation, Testing and Commissioning (SITC) of Audio Visual work(s). The similar work(s) must have involved integration of AV equipment. SITC of TVs/ Displays only, will not be considered as integration of AV equipment.

The contractor will enclose necessary certificates / documents in support of the requirements mentioned at 1. to 4.

For the purpose, "Cost of work" will mean gross value of completed work.
