EXECUTION OF INTERIOR FURNISHING WORKS IN NISM CAMPUS AT PATALGANGA**

National Institute of Securities Markets (NISM) *hereinafter referred as "Institute"* invites applications for registration of contractors for execution of interior furnishing works for value of works **upto Rs. 25 Lakh** in NISM Campus situated at Plot nos. IS 1 & 2 and IS 4 *hereinafter referred as "Campus"*, Patalganga Industrial area, Village: Mohopada (Wasambe), Opp. HDFC Bank, Taluka- Khalapur, District- Raigad, Maharashtra, Pin code: - 410 222.

NISM is a public trust, established by the Securities and Exchange Board of India (SEBI), the regulator for securities markets in India. NISM seeks to add to market quality through educational initiatives. It is an autonomous body governed by its Board of Governors.

Currently, NISM has been operating from its campus situated at Plot No: - IS 1 & 2, Patalganga Industrial area, Village: Mohopada (Wasambe), Opp. HDFC Bank, Taluka- Khalapur, District- Raigad, Maharashtra, Pin code: - 410 222 (near Navi Mumbai). The campus is having a built up area of 7.00 lakh sq. ft. on plot of lands admeasuring about 70 acres.

**The campus requires execution of interior furnishing works in the campus on periodical basis for which it is proposed to empanel contractors for different values of work. This notice is for registration of eligible contractors for execution of interior furnishing works in the campus for value of works upto Rs. 25 Lakh on each occasion. It may be noted that the contractor registered for Rs. 25 Lakh will automatically stand registered for lower values of works and the contractor need not submit separate applications for lower values of works.**

**Eligibility Criteria**

The contractor fulfilling following criteria may apply:

1. Should have its office in Mumbai / Navi Mumbai/ Thane/ Raigad / Pune or Alibag District.
2. Should be registered with GST.
3. The average annual turnover for last three financial year ending March 31, 2021/ March 31, 2022 should not be less than Rs. 22,50,000/-.
4. Should have satisfactorily completed at least any of the following works during the last 7 years:
  - a) Three similar completed works costing not less than Rs.10,00,000/-.
  - or
  - b) Two similar completed works costing not less than Rs.12,50,000/-.
  - or
  - c) One similar completed work costing not less than Rs.20,00,000/-.

The period of 7 years for the purpose of having completed similar works shall be from 01.10.2015 to 30.09.2022.

Similar work(s) shall mean completed work(s) consisting of **“Execution of interior furnishing work(s)”**.

The contractor will enclose necessary certificates / documents in support of the requirements mentioned at 1. to 4.

For the purpose, “Cost of work” shall mean gross value of completed work.

The last date of submission of applications is October 31, 2022.

The interested agency must register itself on <https://www.tenderwizard.com/NISM> by paying registration fee for an amount of Rs. 2,000/- (Exclusive of GST) in order to participate in the process. However, applying for empanelment is free of cost. Class-3 Digital Signature Certificate (DSC) must be required to participate in the process.

Please note that submissions made by email / postal / hand delivery shall not be accepted. No additional or separate documents shall be entertained after the due date of submission.
