**REGISTRATION OF CONTRACTORS FOR  
EXECUTION OF CIVIL WORKS IN NISM CAMPUS AT PATALGANGA**

National Institute of Securities Markets (NISM) *hereinafter referred as "Institute"* invites applications for registration of contractors for execution of civil works for value of works **upto Rs. 25 Lakh** in NISM Campus situated at Plot nos. IS 1 & 2 and IS 4 *hereinafter referred as "Campus"*, Patalganga Ind. Area, Mohopada, Rasayani, Dist. Raigad, Near Navi Mumbai, Maharashtra 410 222.

**Background and nature of work**

NISM is a public trust, established by the Securities and Exchange Board of India (SEBI), the regulator for securities markets in India. NISM seeks to add to market quality through educational initiatives. It is an autonomous body governed by its Board of Governors.

Currently, NISM has been operating from its campus situated at Plot Nos. IS-1 & IS-2, Patalganga Ind. Area, Mohopada, Rasayani, Dist. Raigad, Near Navi Mumbai, Maharashtra 410 222. The campus is having a built up area of 7.00 lakh sq. ft. on plot of lands admeasuring about 70 acres.

The campus requires execution of civil works in the campus on periodical basis for which it is proposed to empanel contractors for value of work upto Rs. 25 Lakh (on each occasion).

**Eligibility Criteria**

The contractor fulfilling following criteria may apply:

1. Should have its office in Mumbai / Navi Mumbai / Thane / Raigad / Pune or Alibag District.
2. Should be registered with GST.
3. The average annual turnover for last three financial year ending March 31, 2022 should not be less than Rs. 22,50,000/-.
4. Should have satisfactorily completed at least any of the following works during the last 7 years:
  - a) Three similar completed works costing not less than Rs.10,00,000/-.
  - or
  - b) Two similar completed works costing not less than Rs.12,50,000/-.
  - or
  - c) One similar completed work costing not less than Rs.20,00,000/-.

The period of 7 years for the purpose of having completed similar works shall be from 01.02.2016 to 31.01.2023.

Similar work shall mean completed work consisting of **"Execution of civil works such as flooring, painting, blockwork, plastering, G.I. / PVC Piping, M. S. fabrication etc."**

The contractor will enclose necessary certificates / documents in support of the requirements mentioned at 1. to 4.

For the purpose, "Cost of work" shall mean gross value of completed work.
