Background and nature of work

National Institute of Securities Markets (NISM) invites applications for shortlisting of agencies for SITC of LED flood lights including high mast and other ancillary works for Cricket Ground situated at Plot Nos. IS-1 & IS-2, Patalganga Ind. Area, Mohopada, Rasayani, Dist. Raigad, Near Navi Mumbai, Maharashtra 410222. **The estimated cost of work is Rs. 1 Crore.**

NISM is a public trust, established by the Securities and Exchange Board of India (SEBI), the regulator for securities markets in India. NISM seeks to add to market quality through educational initiatives. It is an autonomous body governed by its Board of Governors.

Currently, NISM has been operating from its premises situated at Plot Nos. IS-1 and IS-2, Patalganga Ind. Area, Mohopada, Rasayani, Dist. Raigad, Near Navi Mumbai, Maharashtra 410 222. The premises are having a built up area of 7.00 lakh sq. ft. on plot of lands admeasuring about 70 acres.

The broad scope of work will include **Supply, Installation, Testing and Commissioning of LED flood Lights, high mast including its foundation & erection works, power cable laying, feeder panel/ control panel and associated electrical works, etc.**

Eligibility Criteria

The contractor fulfilling the following criteria may apply:

- 1) The contractor should have satisfactorily completed at least any of the following works during the last 7 years:

One similar* work costing not less than Rs. 80 Lakh.

OR

Two similar* works each costing not less than Rs. 50 Lakh.

OR

Three similar* works each costing not less than Rs. 40 Lakh.

The period of 7 years for the purpose of having completed similar works shall be from 01.09.2016 to 31.08.2023.

- 2) The annual average turnover of the contractor should not be less than Rs. 1.80 Crore during the last 3 years ending March 31, 2022 / March 31, 2023.

3) The contractor should have GST registration.

*Similar work shall mean completed work(s) consisting of “**Supply, Installation, Testing and Commissioning of flood lights related works for sports facilities including flood lights high mast, civil foundation, etc.**”

The contractor will enclose necessary certificates / documents in support of the requirements mentioned at 1. to 3. above.

For the purpose, “Cost of work” shall mean gross value of completed work.

Incomplete applications or applications with missing documents will not be considered for shortlisting. **However, the contractor is also advised not to attach un-necessary / irrelevant documents with the application, making it cumbersome for scrutiny. Only documents which have been asked should be submitted to expedite the process.**
4. The Institute reserves the right to inspect the completed similar works and/ or enquire with the various clients to verify the genuineness and to ensure the conformity with the details given. Further, the Institute reserves the right to reject any application, if the quality of the completed work(s) is not found to be satisfactory.
