The estimated cost of work is Rs. 28 Lakh.

**Eligibility Criteria**

The contractor fulfilling following criteria may apply:

1. The contractor should have its office / establishment in Mumbai / Navi Mumbai/ Thane/ Raigad/ Pune.
2. The contractor should have satisfactorily completed at least any of the following work (s) during the last 7 years as on October 31, 2024:

One similar work\* costing not less than Rs. 22,40,000/-

OR

Two similar works\* each costing not less than Rs. 14,00,000/-

OR

Three similar works\* each costing not less than Rs. 11,20,000/-

The period of 7 years for the purpose of having completed similar work(s) shall be from 01.11.2017 to 31.10.2024.

3. The annual average turnover of the contractor should not be less than Rs. 75,60,000/- during the last 3 years ending March 31, 2023 / March 31, 2024.
4. The contractor should have GST registration.

\* Similar work(s) means signage work (s).

The contractor will enclose necessary certificates / documents in support of the requirements mentioned at 1. to 4. above.

For the purpose, "Cost of work" shall mean gross value of completed work.
